<u>Sewer</u> – Report by Trustee Elliott: Had meeting with the City regarding usage and sewer rates for the City and Township. City proposed rate of 9.99/1000 gallons but we have received no confirmation of changes or date of rate hike. Will continue to report as information comes in.

Following several sewer calls that have been deemed as not caused by regular use, a letter has been drafted for all people in the sewer district listing what is allowed to be routed through the sewer system and what has been found to cause problems that is not considered normal usage and may result in charges to the property owners such as grease, toys, flushable wipes,

feminine hygiene products, etc. Motion by Elliott to send this letter to sewer district, seconded by Merchant. Motion carried.

Supervisor LaHaie presented proposed REU price changes for several properties in the sewer district due to building footprint and use changes. (See Attached) Motion by Elliott to forward the list to the city for approval. Seconded by Schramm. Roll call: Merchant—yes, Beebe—yes, LaHaie—yes, Elliott—yes, Schramm—yes. Motion carried.

New Business

Presentation requesting support for the clean up and repair of the Little Black River Watershed. Motion By Elliott to table the subject until more information can be obtained. Seconded by Schramm. Motion carried.

Agreement for Intergovernmental Recycling Program was discussed. Tim MacArthur will look over the agreement. Motion by Elliott to revisit November 1 meeting, Seconded by Schramm. Motion carried.

Supervisor LaHaie brought up the possible rate increases for hall rental. Will discuss at next meeting.

Cemetery – Supervisor LaHaie will meet with a contractor to get an estimate to do tree work at the Maple Grove Cemetery. Work will not be scheduled until spring.

The fire department submitted an estimate for \$2500.00 (70% of which will be paid for by the Township) to resurface the parking lot at the fire hall.
